




The COVID-19 Worker Impact Survey was launched in partnership with seven workforce planning boards that are part of Workforce Planning West. The boards released this survey to help inform the ongoing development of responsive employment-related initiatives. The survey collected 2,568 responses across 16 counties in Southwestern Ontario, including 297 responses in the Sarnia-Lambton Economic Region.

The survey was designed to assess the extent in which a worker's employment status, their occupation, and which sector they are employed might have changed since March 2, 2020.


The COVID-19 crisis has made significant impacts locally and globally in regards to business, livelihoods, and jobs. This survey will help define the impact of COVID on jobs and families and provide insight into what supports are deemed essential by the workforce in Sarnia-Lambton.

Age and Gender Demographics of Respondents



The 297 respondents were primarily female and, although there was representation from all age categories, the majority of respondents were between the ages of 25 and 44 (Figure 1.1). Over half of the respondents indicated they were concerned about having enough food, having enough money to pay their monthly bills as well as pay their rent or mortgage (Figure 1.2).




Impact of COVID – 19 on workers in Sarnia – Lambton

Respondents represented ten occupations with the top three being: Sales and Service, Healthcare, and Education, Law, Social, Community, and Government Services (Figure 1.3). As noted in Figure 1.4, respondents suggested the top four industries that were impacted by COVID-19 include: Retail and wholesale trade, Healthcare and social assistance, Construction and utilities, and Manufacturing. In terms of amount of work, over half of respondents indicated they were working less or not at all due to COVID-19 (Figure 1.5). When asked about current employment status, a majority of respondents reported a loss of work or a switch to working from home (Figure 1.6).

Impact of the COVID-19 crisis on Respondents' Employment Status






Figure 1.7 portrays the industry of respondents. There was representation from 16 industries with the highest portion of respondents indicating they worked in Healthcare and Social Assistance, Retail and Wholesale trade, or Manufacturing.

The results of the survey suggested that the respondents are hopeful for the future. The respondents supported the idea that Sarnia-Lambton will be a stronger community following the COVID-19 crisis (Figure 1.8, 1.9) and they will be able to find or continue their employment after the crisis has ended (Figure 1.10).


Industry of Employment of Respondents
